Hans Boserup brings both international experience and long time solidly grounded and demonstrated commitment to the principles and practice of victim offender mediation. Hans has been trained in mediation (commercial, corporate, family, penal, community, and school, etc.) in the United States, Ireland, and Germany. He is a practicing attorney at law (admitted to the Danish Supreme Court) and a professor teaching mediation at the University of Aarhus. In 1993 Hans Boserup introduced mediation to Denmark by authoring a book and articles on the topic. Other articles and his recent textbook *Mediationsprocessen*, 2001, have followed. In addition, he is part of a research team in mediation at the universities of Lulea, Uppsala and Gotherburg. Hans is a founding member of World Mediation Forum, a founding member of Danish Mediation, and former chair of the Nordic Forum of Mediation. He frequently lectures internationally on mediation. Hans Boserup has formed a European electronic network of mediators with more than 250 participants and has trained more than 2000 mediators in various European and other countries. VOMA is honored to have such an exceptional and outstanding candidate willing to contribute his expertise. *International, Region I-B*

Kevin Duncan, M.A., is a licensed social worker and mental health counselor with extensive experience in planning and implementing programs which serve adolescents and their families. Kevin has nineteen years experience working in a variety of mental health settings, including residential, educational, juvenile corrections, private psychiatric hospital settings, and managed care roles. He implemented and continues to facilitate a Juvenile Offender Mediation Program in Iowa. This program integrates traditional victim offender mediation processes with solution-orientated interventions, education on cognitive distortions, relapse preventions, offense cycles, and the development of victim empathy. The program has maintained a recidivism rate of less then 5% over four years. He was the lead coordinator for the development and implementation of adult and juvenile drug courts in Marshall County, which integrated the principals of Balanced and Restorative Justice. His primary interest is in the practical application of Victim Offender Mediation and BARJ concepts. Kevin also provides in home counseling services, works part-time at a mental health center and facilitates a shoplifters program. *USA*, *Region C*

Sheri Gatts has been with the CAP Division of Youth Services of Southern Wisconsin as Coordinator of the Victim Offender Conferencing Program since May 1997, and Coordinator of Community Peer Court since February 2003. YSOSW provides services for victims of juvenile crime, court involved juveniles and their families. Sheri recruits, trains and supervises volunteers; screens referrals; coordinates Peer Court Programs in three communities; and facilitates conferences between victims and their offenders, victim impact panels, and accountability groups for juveniles who have offended. For the past fifteen years Sheri has provided local, statewide and national training on a variety of topics, including restorative justice, victim offender mediation, cultural awareness, working with volunteers, child abuse and neglect, adoption issues for children with special needs, and children's mental health. She is a certified trainer for VOMA, and has presented at three VOMA Conferences and Training Institutes on a variety of topics, including full-day sessions on racial and cultural issues in mediation, and understanding victimization (2003). *USA*, *Region C*

Martin McAnallen has spent 27 years within Probation and Corrections working as a senior practitioner/ case manager with high risk and listed dangerous offenders, with the philosophical base of restorative justice at the core of his endeavors. He has eighteen years of experience in the practice of mediation. He had a pivotal role in the founding of the Northern Ireland Conflict Mediation Association, more recently known as Mediation Northern Ireland, a widely respected NGO working to transform and manage conflict through the promotion and practice of mediative dialogue and creative responses to the conflict in Northern Ireland. Martin is proud of having coordinated the first formal victim offender mediation with a crime of severe violence in 1978 and the first formal youth conferences in Ireland as recently as 1998. In all his work he has remained conscious of the intrinsic strengths of his people with a strong restorative tradition which has its origins in their own tribal history dating back to the ancient Brehon laws of the 7th and 8th centuries as well as their vibrant oral tradition (translated; we talk ourselves into and then out of conflict!!). Both these traits provide the legacy and in turn the framework to construct a future away from violence. *International, Region I-B*

Andrea Verswijver has been working in the field of Restorative Justice for the last eight years and began as a volunteer mediator in Juvenile Probation. She participated as an International Monitor of the Truth and Reconciliation Commission for the National Lawyers Guild in South Africa and helped write the only official international observation report. Her work experience includes Criminal Legislative Research, managing Court Mediation Programs and creating a Violence Prevention program for young Native Americans. With an M.S. in Conflict Analysis and Resolution, with a focus on Restorative Justice, and an M.A. in Latin American Studies, Andrea uses her knowledge to consult with schools and detention centers on the uses of Restorative Justice Practices to promote inter-racial understanding, non-violence and enhance learning or rehabilitation.
